Invitation to Bid for

Design, Supply, Delivery, Installation, Testing and Commissioning of 2 Units Filter Vessel Incorporating Katalox Light Filter Media

The Tabaco City Water District, through the TAWAD General Fund of 2016 intends to apply the sum of Php 2,074,000.00 being the Approved Budget for the Contract (ABC) to payments under the contract for Solicitation No. TAWAD2016-BID-04. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Tabaco City Water District now invites bids for Design, Supply, Delivery, Installation, Testing and Commissioning of 2 units Filter Vessel for 10 Liters per Second Capacity Incorporating Katalox Light Filter Media.

Delivery of the Services is required for 60 calendar days. Bidders should have completed, within 5 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Interested bidders may obtain further information from Tabaco City Water District and inspect the Bidding Documents at the address given below during office hours from 10:00am to 11:30am and 1:00pm to 4:00pm. Pre-bid conference shall be on June 30, 2016 1:30 p.m.

A complete set of Bidding Documents may be purchased by interested Bidders on *June 30 to July 12, 2016* from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of *Php 5,000.00*.

Bids must be delivered to the address below on or before *July 12, 2016 1:00pm*. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 8.

Bid opening shall be on July 12, 2016 1:30 pm at the TAWAD Conference Room. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The *Tabaco City Water District* reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
