Invitation to Bid for Supply and Delivery of Various PVC Pipes

The Tabaco City Water District, through the TAWAD General Fund of 2017 intends to apply the sum of Php 1,954,680.00 being the Approved Budget for the Contract (ABC) to payments under the contract for Solicitation No. TAWAD2018-BID-04. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Tabaco City Water District now invites bids for Supply and Delivery of:

Delivery is required for 60 calendar days. Bidders should have completed, within 5 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

Interested bidders may obtain further information from *Tabaco City Water District* and inspect the Bidding Documents at the address given below during office hours from 8:00am to 12:00nn and 1:00pm to 5:00pm.

A complete set of Bidding Documents may be acquired by interested Bidders on *November* 14 - 26, 2018 from the address below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of *Php* 3,000.00.

The Tabaco City Water District will hold a Pre-Bid Conference on November 14, 2018 at TAWAD Conference Room which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat at the address below on or before *November 26, 2018 1:00pm*. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on November 27, 2018 1:30pm at the TAWAD Conference Room. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The Tabaco City Water District reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
