



## **INVITATION TO BID FOR THE Supply and Delivery of 3,300 pieces Water Meter 15mmØ**

The *Tabaco City Water District*, through the *TAWAD General Fund of 2020* intends to apply the sum of *Php 3,960,000.00* being the *Approved Budget* for the *Contract (ABC)* to payments under the contract for *Solicitation No. TAWAD2019-BID-03*. Bids received in excess of the *ABC* shall be automatically rejected at bid opening.

The *Tabaco City Water District* now invites bids for *Supply and Delivery of 3,300 pieces Water Meter 15mmØ*, with the following specifications:

15mmØ Water Meter  
Direct Magnetic Transmission  
Multi Jet Velocity, Dry Type Register  
Qmin = 30 l/h, Qmax = 3,000 l/h  
Max Water Pressure = 10 kgf/cm<sup>2</sup>  
Anti Magnetic, Unidirectional Flow  
Brass Body & Brass Lid Cover Seal  
ISO 4064 Compliant  
TAWAD Logo engraved at Registry Plate

Delivery is required for *60 calendar days*. Bidders should have completed, within *5 years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

Interested bidders may obtain further information from *Tabaco City Water District* during the pre-bid conference on *November 29, 2019 1:30pm* and inspect the Bidding Documents at the address given below during *office hours from 08:00am to 12:00nn and 1:00pm to 5:00pm*.

A complete set of Bidding Documents may be purchased by interested Bidders on *November 29, 2019 to December 12, 2019* from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of *Php 5,000.00*.

Bids must be delivered to the address below on or before *March 12, 2019 5:00pm*. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 8.

Bid opening shall be on *December 13, 2019 1:30pm* at the *TAWAD Conference Room*. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The *Tabaco City Water District* reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
