INVITATION TO BID FOR THE Drilling of Proposed Production Well at Pinagbobong, Tabaco City

The Tabaco City Water District, through the TAWAD General Fund of 2020 intends to apply the sum of Php 2,800,000.00 being the Approved Budget for the Contract (ABC) to payments under the contract for Solicitation No. TAWAD2019-BID-04. Bids received in excess of the ABC shall be automatically rejected at bid opening.

Delivery is required for 60 calendar days. Bidders should have completed, within 5 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

Interested bidders may obtain further information from Tabaco City Water District during the pre-bid conference on December 04, 2019 1:30pm and inspect the Bidding Documents at the address given below during office hours from 08:00am to 12:00nn and 1:00pm to 5:00pm.

A complete set of Bidding Documents may be purchased by interested Bidders on *December 04, 2019 to December 16, 2019* from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of *Php 5,000.00*.

Bids must be delivered to the address below on or before *December 16, 2019 5:00pm*. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 8.

Bid opening shall be on *December* 17, 2019 1:30pm at the TAWAD Conference Room. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The Tabaco City Water District reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
